



Mark M. Wiechnik

Mark Wiechnik is a partner in the Firm's Community Association Group. His practice is focused on construction defect litigation, including defective roofs, exterior cladding (EIFS) systems, balconies, concrete, foundations, parking facilities and windows. In addition, Mr. Wiechnik advises community associations in pre-litigation negotiations with respect to transition from developer to unit owner control. Over the last 5 years alone, he has obtained more than \$15 million for his clients suffering from buildings with severe construction defects.

Mr. Wiechnik has experience representing associations, as both plaintiffs and defendants, in litigation arising from violations of the New Jersey Condominium Act and the Planned Real Estate Development Full Disclosure Act (PREDFDA), breaches of contract by association vendors and contractors, Municipal Services Act violations by municipalities, improper governing document amendments by developers, breach of fiduciary duty by developer-appointed trustees and violations of governing document provisions and restrictive covenants by unit owners.

Mr. Wiechnik is a regular speaker on the basics of construction defect litigation and related insurance matters. He has given presentations to attorneys, engineers, architects and contractors as part of the National Business Institutes' continuing education seminar series.

In 2015 Mr. Wiechnik, and associate Breanne DeRaps, successfully argued before the Appellate Division of the Superior Court of New Jersey in Cypress Point Condominium Association, Inc. v. Adria Towers, LLC that unintended and unexpected consequential damages caused by a subcontractor's defective work constitute both "property damage" and an "occurrence" under a standard commercial general liability policy.

The insurers for Adria Towers appealed that decision, and in August 2016, the New Jersey Supreme Court delivered a [unanimous decision](#) affirming the Appellate Division ruling. Cypress Point marked a significant change with respect to the insurance coverage potentially owed for construction defect claims in New Jersey, substantially strengthening home owners association's position when they seek redress for damage related to shoddy work during construction.
