**ANSELL GRIMM & AARON ATTORNEY ROBERT AUFSEESER DISCUSSES THE PITFALLS OF NON-JUDICIAL SETTLEMENT AT THE NEW JERSEY INSTITUTE OF CONTINUING LEGAL EDUCATION**

***Wills, Trusts & Estates Attorney Robert I Aufseeser to Address Tax, Estate Planning, and Elder Law Legal Professionals at the 80<sup>th</sup> Semi-Annual Tax and Estate Planning Forum***

New Brunswick, NJ – Robert I. Aufseeser, an attorney in Ansell Grimm & Aaron’s Wills, Trusts & Estate Practice, will speak to attendees of the New Jersey State Bar Association’s December 6<sup>th</sup> “Semi-Annual Tax and Estate Planning Forum,” sponsored by the New Jersey Institute of Continuing Legal Education and held at the New Jersey Law Center.

From 9 a.m. to 5 p.m., attendees will hear Aufseeser and other panelists discuss 2018’s most pressing issues in estate planning and taxation, and look forward to what lawyers and their clients will face in 2019. Among the topics are: Aufseeser’s discussion of the pitfalls in non-judicial settlements of estates, estate administration options after the repeal of the New Jersey Estate Tax for wills containing provisions for Credit Shelter and QTIP Trusts; unusual proceedings for insolvent estates under court Rule 4:91 and why decedents cannot file for bankruptcy, new estate developments and regulations; as well as an analysis of proper and allowable distributions from special needs trusts.

“In 2018, the Tax Cuts and Jobs Act and other initiatives led to an enormous change in trusts and estates administration nationwide,” says Aufseeser. “The impact locally, under New Jersey was also significant and we expect further evolution in trust and estates administration in 2019.”

The “Semi-Annual Tax and Estate Planning Forum” has been approved by the Board on Continuing Legal Education of the Supreme Court of New Jersey for 7.9 hours of total CLE credit.
