BYLAW AMENDMENTS TO ADD UNDER RADBURN AT CAI-NJ SEPT. 12<sup>th</sup> ROUNDTABLE**

***Community Association Practice Leader David Byrne to Address Attendees at the 2019 Homeowner  
Leader Best Practices Roundtable Discussion and Cocktail Reception***

PRINCETON, NJ – What types of amendments should associations consider now that New Jersey’s Planned Real Estate Development Full Disclosure Act has been amended by Radburn, making it significantly easier for an association to amend its bylaws? That is the topic for a discussion led by David J. Byrne, chair of Ansell Grimm & Aaron’s Community Association Practice Group at the New Jersey Chapter of the Community Associations Institute 2019 Homeowner Leader Best Practices Roundtable Discussion and Cocktail Reception, Thursday, September 12, 2019 at the Buona Sera Restaurant in Red Bank, NJ.

“Because of what has been called the ‘Radburn Bill,’ associations will have a much, much easier time amending bylaws. Before ‘Radburn,’” says Byrne, “a community’s bylaws could be amended only by the owners and often only upon the approval by a supermajority of them.”

Byrne will discuss how a community can best take advantage of the new law in the form of “amendments to bylaws.”
